Introduction

Kenya is administratively divided into 47 Counties with 44 different ethnic communities. Before the creation of these Counties as per the 2010 Constitution, information flow in the rural areas was asymmetrical. The communities in these Counties are trying to catch up with development as propagated by their leaders based on the County Integrated Development Plans (CIDPs). The development agenda has however remained a challenge. With the gaps identified, COHEDA in partnership with relevant and stakeholders seeks to power the school going girls through this concept paper.14 percent of the pregnancies in Kenya end up in abortions. Most of the aforementioned abortions are done by unskilled people in conditions that do not meet minimal medical standards and thereafter are not followed with appropriate post-abortion care. These abortions account for about 2600 deaths of women and girls annually in Kenya.

Purpose

One major challenge that has emerged in almost all the Counties is what is commonly referred to as teen pregnancies. This predicament is escalating at an alarming rate, ranking Kenya as third globally. For example, during the months of January and February 2022, there were 45,724 pregnancies of girls between 10 – 19 years old averaging 775 a day. (Ministry of Health Report) The teenage pregnancy and motherhood rate stands at 18%. It has been noted that lack of adequate information to these girls coupled with unclear guidelines and policies have contribute to this challenge. Equally social and cultural practices within the different Counties also contribute immensely to this challenge. Some few organizations and personalities have used their platforms to address this issue in some parts of the country, but their intervention has not made a significant impact due to diverse challenges. However, there are still notable gaps to be addressed.

Project Description

9

COHEDA has come up with a unique approach to the programme of unwarranted pregnancies among school going girls. The implementation strategy seeks to harness the synergistic relationship between the role of County Women Representatives and other Honorable Women Leaders in Parliament as authoritative personalities in policy making. The programme calls for collective responsibility and partnership involving schools, religious institutions, local women leaders, local women groups, dispensaries, County Governments as well as the Ministry of Health and the Ministry of Education. The availability of technical skills and professional guidance within these ministries will provide better and appropriate information, this will be the most efficient structure for information dissemination in the implementation of the programme.

Objective

The main objective is to provide age-appropriate information to the girls from age 10 years old up to attainment of adulthood about their reproductive health & organs, their changes in growth and body emotions, dangers of entering sexual acts at an early age, which include but not limited to, unintended risk of pregnancy, unsafe abortions, perinatal complications such as low birth weight, post-natal depression, among others and consequences of the same, not to mention the socio-economic mess caused due to unintended pregnancy among girls of this age group. This will take place in all the schools in Kenya during the school calendar for the purpose of creating self-awareness and empowerment for sound decision making in their normal interaction within the society. We aim at reaching at least 60% of the pre-pubescent to adolescent girls in the 31200 primary schools and 1250 secondary schools throughout the Country.

Implementation Strategy

The Programme will mainly involve schools and use trained teachers by adopting the classroom format where all the educational content developed and packaged under the scheme of work. The lesson plan model will be used to disseminate knowledge to the girls. The literature accuracy from Ministry of Health will form the basis of this information. The need to institutionalize this programme in a wholesome manner will have an impact.

The highlights of our approach which include the identified gaps involve the following;

- i) Teaching them about their body changes during and after puberty.
- ii) Training in managing their emotions for sound decision making concerning their sexuality.
- iii) Availing counseling and mentorship pathways by encouraging communication between the girls and school counselor, female religious leaders and responsible female members of the society.
- iv) Liaising with willing corporate and NGOs to provide the girls essential items such as sanitary towels, under garments and hygiene products to keep the girls comfortable and focuses in school.
- v) Deal with social and cultural issues which promote unwarranted pregnancies among young school going girls.

The Programme will also involve parents by organizing them within their respective churches/mosques especially during parents' days in schools where dissemination of information will be provided reminding and enlightening them on the opportunities they already have towards proper ways of parenting.

Sustainability

Working closely with and under the office of Women Representatives in the Counties will form part of the sustainability of this programme.

Involving all women leaders in Parliament to look into the policy involving guidance and counseling docket in schools and strengthening it to accommodate the objectives of this programme.

The involvement of religious institutions in this programme will be integrating the Church Pastoral Programmes and Mosques curriculum for sustainability purposes.

Output

The Programme's output will include the number of girls reached, the number of schools and churches and Mosques involved in this programme, the number of trainings taking place in schools and the number of parents/guardians sensitized on parent's days.

Impact

Increase greater understanding and awareness in at least 60% of the school going girls about their body changes, their rights and obligations, the effects of their decisions and actions as concerns the prevention of unwarranted early pregnancies. The burden of unwarranted pregnancies in school going girls, their parents/guardians, careers and the community at large will ease. Focusing on the broader picture, budgeted funds allocated by Government for Educational purposes will be optimally utilized to realize the Education Objective for every Kenyan girl. The involvement of the Office of County Women Representative in Parliament will be actively utilized in solving numerous girls demand needs in the Country.

Monitoring and Evaluation

Monitoring and Evaluation will be an ongoing process to measure and document the programme progress, achievements and have accountability for the resources used. This will involve determining if the goal or aim of the programme was achieved or not.
